

What is Coronavirus?

Coronavirus Disease 2019 (COVID-19) is a respiratory disease caused by the Severe Acute Respiratory Syndrome (SARS)-CoV-2 virus.

The current mutation is a new strain of the SARS virus and no individual has any immunity prior to an exposure. The CDC has reported that testing has begun on a vaccine but for now, everyone should prepare and plan for possible impacts resulting from COVID-19. It has spread from China to many other countries around the world, including the United States.

With the recent emphasis on Novel-Coronavirus, COVID-19, exposures and ongoing employer obligations, Tri State Restorations wants to remind you of the importance of social distancing and provide you with tools and resources to help protect you, your family and your workers from this and other environmental exposures.

While there are many reported cases of COVID-19, nationally and internationally, it is important to review all facts concerning this virus and implement universal precautions to prevent this virus from spreading and affecting jobsites across the nation.

What should you do in response?

Everyone should follow these general practices to help prevent exposure to coronavirus:

- Frequently wash your hands with soap and water for at least 20 seconds.
- If soap and running water are not available, use an alcohol-based hand rub that contains at least 60% alcohol.
- Avoid touching your eyes, nose, or mouth with unwashed hands.
- Avoid close contact with people who are sick.
- Wear cloth face coverings when out in public spaces.

Facility owners and employers of workers with potential occupational exposures to coronavirus should follow these practices:

Assess the hazards to which workers may be exposed.

Evaluate the risk of exposure.

• Select, implement, and ensure workers use controls to prevent exposure, including physical barriers to control the spread of the virus; social distancing; and appropriate personal protective equipment (PPE), hygiene and cleaning supplies.

Maintaining indoor environmental conditions is of primary importance. Clean and disinfect

interior occupied spaces, furnishings, and mechanical systems.

• Test all systems before re-occupancy. Disruptions in water and HVAC services to your facility can cause many unwanted challenges.

Protecting my business and employees:

Employers and employees should also review company policies on sick leave, family medical care leave and other federal regulations protecting employer and employee rights.

1. What are Universal Precautions related to communicable exposures in the workplace?

Using precautionary techniques and/or personal protective equipment to prevent exposures and the unnecessary exposures in the workplace.

2. What should an employee do if they experience fever or show signs of respiratory issues before going to work?

Handwashing Protocol cont.





Rinse your hands well under clean, running water.





Dry your hands using a clean or disposable towel, or air dry them. Avoid hand driers.

Feeling Sick? Stay Home.

Stay home, (except to seek medical care from a licensed health care provider), avoid public areas, public gatherings and public transportation. Remember, if you are showing signs of sickness self-isolate and stay away from family members and pets that could transmit the virus to others. Don't forget to clean and disinfect surfaces regularly including items you touch repeatedly and if possible, use disposable cups, glasses and utensils to minimize additional exposure.

When do you seek medical assistance?

If you develop any of the following emergency warning signs for COVID-19 get medical attention immediately: trouble breathing, persistent pain or pressure in the chest, new confusion or inability to arouse, bluish lips or face.
